Question 1:

- a) Evaluating electrical power consumption requirements;
- b) Developing specifications for a power generation system;
- c) Installation and testing of a power generation system. “

To:

“The proposed resource must have a minimum of twelve (12) months demonstrated experience in the last five (5) years in any combination of at least two (2) of the following...”

Answer 1:

2 - **DELETE** at Attachment 1 to Part 4 - Technical Criteria, MT6 in its entirety and **REPLACE** with the following:

MT6: The proposed resource must have a minimum of twelve (12) months demonstrated experience in the last five (5) years in any combination of at least two (2) of the following:

- a) Evaluating electrical power consumption requirements;
- b) Developing specifications for a power generation system;
- c) Installation and testing of a power generation system.
