Amendment 001

Requirement: Request for Regional Individual Standing Offer for the supply of Milk, Butter, Ice Cream and other products on an as and when required basis.

The above mentioned Solicitation is hereby amended to reflect questions received from a bidder and the responses by the consignee.

1) Page 15 – Shelf Life – milk supplied to have a minimum of 12 days before expiry date.

Q. Is there any leeway on this requirement to be changed to 7 days?

R. For CFB Trenton/CFS Alert: no, it is to remain 12 days due to dairy products being shipped to CFS Alert and also being supplied to aircraft, which have a very strict policy on quality the date cannot move on the time before best before dates on any fresh milk.

For CFB Kingston: 7 days is acceptable.

2) Annex “C” – Pricing Basis A – item #3 and item #4 seem to be the same product – 2% milk – 20 Lt size. The only difference appears to be one is in a bag and one is in a box. Our product is sold as a 20 Lt case – there is a bag inside of the box.

Q. Would we quote the same item for both of these?

R. Item 1C011 are the same, quote on 20 Lt 2%

3) Same as question #2 above for items #5 and item #6 – 20 Lt skim milk. Our product is a 20 Lt bag inside of a box.

Q. Could you please provide some direction on this?

R. Same for 1C014

4) Annex “C” – Pricing Basis A – item #28, item #29 and item #30 - #28 is a 125 gm size? If so, this is not sold as an individual item but either as a flat/case of 12 x 125 gm. We could provide the individual price on a 125 gm cup of yogurt, but would need to sell as a case of 12 x 125 ml.

Q. Is this acceptable?

R. Quote individual with a note sold by the case.

Q. Could you please provide the difference between #29 and #30?

R. 1K027 Quote on #29 delete #28, #30.
