Questions and answers

Question #1:

Could Solicitation No. - 2B0KB-130262/A be extended by 2 weeks?

Answer #1:

It would be premature for the Crown to extend the closing date before the period of question is closed (article 2.3 of the solicitation). Bidders should submit all questions and requests for extension before June 19. Once the period of question is closed, the Crown will consider all requests for extension received and advise bidders accordingly.

Question #2:

In consideration of the extensive and complex requirements, along with the significant amount of material being requested in the response, we request an extension to the bid submission date to August 31, 2012.

This is the amount of time required for Suppliers to fully assess the requirements and prepare and submit a response to SSC. It is also consistent with the timeframes normally provided to Industry to respond to a bid of this nature.
