Questions and Answers

- Q1:** I understand the entire Remediation Standing Offer has an anticipated expenditure of \$15M; however, as mentioned, the Set-aside portion of the Standing Offer has been valued at \$250,000K for one qualified company over a 3 year period while the Non Set-aside is anticipated to provide 5 contracts worth \$15 million over the same 3 year period. In the past, it has been our experience that the Federal Standing Offers have been proportional between the non set-aside and set-aside programs (i.e. the value of the set-aside would be approx. \$2-3M). Can you please let me know why there is such a significant difference?
- A1:** The entire requirement, including the Set-aside, is \$15,000,000, calculated as described on page 63 of 63 of E0276-110680/A. The total value of the requirement, and the proportion for the Set-aside, is based on the actual spend from the previous supply methods.

All clauses and conditions remain unchanged.
