1) Refer to page 5 of 33 at "SI5 Changes to Clause R1410T (2011-05-16) General Instructions to Proponents (GI)":

DELETE:

"SI5 CODE OF CONDUCT CERTIFICATIONS - CONSENT TO A CRIMINAL RECORD VERIFICATION

QUESTIONS AND ANSWERS:

Question 1: Could you please define the specific location of the "ridge south of PEARL lab" gravel source?

Answer 1: At GPS points N80deg-01min-19.7sec & W086deg-21min-59.6sec and roughly 375meters west of north/south road from Upper Paradise to the PEARL Lab.

Question 2: The project contract award date of August 27th makes organizing the necessary logistics (cargo aircraft, drilling rig, etc.) and completing the field work before the onset of winter extremely challenging. Would it be possible to accelerate the closing date and/or project award? Alternatively, I suggest the field work should be deferred until summer 2013.

Answer 2: All efforts possible need to be made to have work done this field season as all 3 large infrastructure projects schedules hinge on this work being done this season.

Question 3: Could you please list the weight restrictions on the runway during the summer months? (RFP Section 2.4.1.10)

Answer 3: Weight restrictions is any aircraft over 65000 lbs must contact Eureka SPM (Station Program Manager) for info on runway conditions for flight planning.

See the Canada Flight Supplement which states the following:

"100092 CYRB EUREKA

CYEU AMEND PUB: RWY DATA: RCR TO READ: OPR LTD WIN MAINT.

RWY STRENGTH AND COND SUBJECT TO SEASONAL AND CLIMATIC VAR.

ACFT 65000 LB AND OVER PPR"

Question 4: Is the station loader and operator available to drag/skid equipment around to the various drilling sites?

Answer 4: Most likely but advanced notice must be provided to Eureka SPM for work planning purposes.

Question 5: Is the station van and/or quad bikes available for use to the field teams?

Answer 5: The Eureka vehicles and equipment are for the use of Eureka staff personnel only. Contractors can make arrangements to have a driver and vehicle provided to access various areas in Eureka with proper advance notice of date and times required at an additional cost. See Fee schedule (See ATT 7) attached.

Question 6: Will gasoline and diesel be provided to the field team or will we be charged for the use of station stores?

Answer 6: Diesel and gas is normally only for Station use and most contracts are to include the delivery of fuel on site that will be required for contractor's task completion. Depending on amounts required and the urgency , perhaps arrangements can be made with Eureka SPM.

Question 7: Is the size of the field crew limited by the available station accommodations during the proposed drilling season? (September-October)

Answer 7:Yes, but there should be ample room at the Station depending on the size of the field crew. Smaller field crews of 3 - 5 personnel are normally not a problem.

Question 8: Could you please give us the anticipated 2012 sealift schedule?

Answer 8: Cut off date for loading on NEAS (Nunavut Eastern Arctic Shipping) ship going from Valleyfield to Nanisivik is around July 23rd. CCG (Canadian Coast Guard) estimated ETA for Nanisivik to pick up equipment for Eureka is around August 19th and should be in Eureka late August depending on ice conditions and priority schedules.

If your bid has already been forwarded and you wish to revise the same, this revision should be mailed in a sealed envelope and reach the Bid Receiving Unit identified on Page 1 before the closing date. The bid number and closing date are to be shown on the sealed envelope.
