Question 1:

I have been revising the bid information in regards to file number MCT-2-35066 (018). The drawings dimension are within our modular fabrication and transportation. However the interior divisions are different than what we usually design for modular.

Are we allowed to modify this plan slightly or not? I want to discuss different options with my engineers but wanted to see the flexibility of changes allowed first.

Answer:

No, the bidders are not allowed to change location of interior walls. Location of the interior walls were designed to meet requirements of `` (CSA B651-04) Accessible Design for the Built Environment ``
