**Amendment 003 is raised for the following:**

(1) to respond to Bidders questions and amend the Basis of Payment as follows:

**Question 1:**

In Attachment 1 to Part 4 Technical Criteria pg 1 of 10, mandatory requirement to "Provide resumes of key personnel identified to successfully complete the project".

Are we required to provide resumes for all the roles identified in the Technical Criteria Mandatory Criteria table even if we don't feel all of the roles are required to successfully fulfill the project? Or are we able to provide resumes just for the team we have identified for the successful completion of the project?

**Answer 1:**

Only the resumes of personnel working on the project are required.

**Question 2:**

In the Request for Proposal, page 18 of 91 says Firm Lot Price... but pg 30 of 91 basis of payment form makes it seem Time and Materials.

Could the Crown please clarify if the Contract is going to be Firm Lot Price or Time and Materials?

**Answer 2:**

The Basis of Payment - Firm Lot Price is amended to The Basis of Payment - Limitation of Expenditure in accordance with Annex B, Basis of Payment.

The Basis of Payment is amended as follows:

In Part 7, Resulting Contract Clauses, section 6:

**DELETE in its entirety:** 6.1 Basis of Payment - Firm Lot Price

**INSERT in its place:**

**6.1 Basis of Payment****6.1 Limitation of Expenditure**

The Contractor will be reimbursed for the costs reasonably and properly incurred in the performance of the Work, as determined in accordance with the Basis of Payment in Annex B, to a limitation of expenditure of \$\_\_\_\_\_ (to be determined at contract award). Customs duty are included and Goods and Services Tax or Harmonized Sales Tax is extra, if applicable.
