This solicitation amendment is to provide clarification regarding the Solicitation.

PART A: QUESTIONS

Q1-1. I am confused by the difference from the Level of Effort described in Annex A for each SOW description versus the Estimated usage requirement forming part C of the quantity of work formula in the Basis of Payment tables in Annex B?

For instance: In Annex A, 7. SCOPE OF WORK, each position description's ends with a "Level of Effort" statement;

- A. Service Desk Technician
A9. Level of Effort 1.0 Person years
- B. Audio Visual Technician
B9. Level of Effort 1.25 Person years
- C. Network Administrator
C9. Level of Effort 3.25 Person years
- D. Computer Maintenance Technician
D9. Level of Effort 3.0 Person years
- E. Programmer/Webmaster
E9. Level of Effort 1.0 Person years

In the tables in Annex B. "Est. Usage [C]" indicates"

- 1.1 Service Desk Technician Est. Usage [C] = 1.50 (as per above this should be 1.00 as Number of days indicates 462 days)
- 1.2 Audio Visual Technician Est. Usage [C] = 1.00 (as per above this should be 1.25 as Number of days indicates 462 days)
- 1.3 Network Administrator Est. Usage [C] = 3.00 (as per above this should be 3.25 as Number of days indicates 462 days)
- 1.4 Computer Maintenance Technician Est. Usage [C] = 2.50 (as per above this should be 3.00 as Number of days indicates 462 days)
- 1.5 Programmer/Webmaster Est. Usage [C] = 0.75 (as per above this should be 1.00 as Number of days indicates 462 days)

Further: Tables 2.0 and 3.0 are for 1 year options therefore "Number of Days [B]" should be 261 in all cases vice 462 as stated, Est. Usage factors should also reflect the same multipliers indicated above.

Please inform me as to the intent of these differences or if in fact they are errors?

A1-1. The differences between the Annex A, 7. Scope of Work and Annex B, Basis of Payment are errors. The "Level of Effort" stated in the Scope of Work is correct.

Yes the number of days are incorrect in Tables 2.0 and 3.0 for the 1 year options. The number of days should be 261 and the estimated usage the should be the same as Annex A, 7. Scope of Work.

The number of days for the contract period are also incorrect, the correct number of days is 522.
