This Solicitation amendment is raised to answer questions received from Bidders.

A. QUESTIONS AND CORRESPONDENT ANSWERS:

QUESTION 1

Amendment #9 still does not clarify an important question.

Do the 5 contracts referenced to meet M1/R1:

- (a) Need to be in the same 24 month period within the past 8 years OR
- (b) Can they be in different 24 month periods over the past 8 years.

ANSWER 1 - As per solicitation amendment 009, the changes made by Canada to Corporate Mandatory Criteria M1 and Appendix A of Annex B made it clear that Bidders are to provide a maximum of 5 contracts demonstrating that the required Minimum Billable Days per category were provided within a total of 24 months over the past eight years. Furthermore, as indicated in R1, Bidders that have exceeded the required Minimum Billable Days per category in Corporate Mandatory Criteria M1 will be given points as described in the Corporate Rated Criteria R1. As such Corporate Mandatory Criteria M1 and Corporate rated Criteria of the solicitation amendment 009 remain unchanged.

The solicitation closing date also remains unchanged.
