Amendment #002 is being raised to extend the closing date, to answer 9 questions received, and make changes to the Minimum Specifications in Annex A.

Questions and Answers:

Question 1. Can the connection to the unit from a solar panel be a 5 pin or USB connection as long as the unit is charging/operational?

Answer 1. No, the compatibility with existing asset trackers currently owned by Canada is crucial in case of breakdowns.

Question 2. What is the significance of the lithium battery?

Answer 2. Lithium batteries are used in other systems carried by our members operating in remote arctic locations and have been proven to retain a charge for much longer periods of time and do not drain as quickly as other types of batteries. The units will be deployed throughout the north in isolated communities where average temperatures during the winter months will be -30 to -40 and below. Units will be stored periodically at these average temperatures. Also, it offers more flexibility compared to a 12 volt cigarette lighter.

Question 3. Can the lithium battery pack be replaced by another source of power?

Answer 3. No. Please refer to Answer 2.

Question 4. What does Canada consider to be a "transmission"? (i.e. Position report, text message, canned text message, encrypted, etc.) Different types of transmission require more or less data.)

Answer 4. All types of transmissions are included.

Question 5. Is there a minimum monthly transmission amount to be included in the offered airtime data plan for 60 pooled unites?

Answer 5. Yes, a minimum of 50,000 transmissions per month is required.

Question 6. In the financial bid, would Canada like a monthly, quarterly, or yearly operating cost and how is this to be expressed, by 1KB is the industry standard?

Answer 6. Financial bids must include all costs related to meeting the Minimum Specifications as well include all delivery costs and must be expressed as "Firm Unit Price" and then as an "Extended Price".

Question 7. Could you please clarify "pay as you go"?

Answer 7. Prepaid airtime data which is consumed by usage.

Question 8. There is no mention of software application charges. Would Canada like these charges included in the airtime portion of the financial bid?

Answer 8. Please refer to Answer 6.

Question 9. Is Annex C to be filled out?

Answer 9. Annex C is not mandatory unless you are bidding as a qualified Aboriginal firm.
