Please refer to Annex "A" - Statement of Work. It does not state that every delivery truck must be equipped with lift gate / tailgate. But it states the following in article 3. Warehouse Equipment and Handling Aids

The Offeror agrees to maintain

- 1) A powered forklift capable of reaching the highest location in the warehouse.
- 2) A powered forklift or "docker" for use in loading and unloading, capable of transporting palletized material in and out of transport vans and of stacking pallets.

Question 9:

Are delivery trucks to provide white blanket service? If yes, what percent of daily deliveries are required?

White Blanket Service is also known as White Glove service. It is similar to a situation when a moving company transports your household items to another location. In this case, I would be referring to items of high value such as a photocopier or any other high value of this scope that requires delivery not only to the destination dock but perhaps right to the actual location within the facility based on the level of security in place.

Answer 9:

Though Annex "A" - Statement of Work does not mention white blanket service, this kind of service may be needed depending on the request of Identified Users.

There are no data available to provide the percent of daily deliveries that require such white blanket service.
