On the cover page of the Request for Proposal in the block "Solicitation Closes" the date has been changed from March 16, 2012 to March 23, 2012.

Annex B - Questions and Answers

Question 1:

On page 6, under Section II: Financial Bid, item b) iv) the estimated funding is listed as \$160,000.00 for the "Contract resulting from the bid solicitation. Is this amount for the three (3) year proposed contract period OR for the three (3) year proposed contract period plus the two (2) option periods?

Answer 1:

Estimated funding is for the three (3) year proposed contract period plus the two (2) option periods.

Question 2:

On page 18, under section 2.1.3., the Statement of Work stipulates that "the Contractor will create and maintain the Website. 1- Is it the intention of the solicitation that the Contractor will provide access to its own drug information website with small modifications (if needed) to accommodate pharmacists from the Canadian Forces (CF) OR that a website exclusive to CF pharmacist will be created and maintained by the Contractor. 2- Is the cost of creating and maintaining said website included in the total hourly rate (as proposed in the table of the Financial Bid) OR a separate cost to be negotiated with the Technical Authority after award of the contract.

Answer 2:

The Contractor will provide access to its own drug information website with small modifications (if needed) to accommodate pharmacists from the Canadian Forces (CF).

Question 3:

It is unclear as to what the "Extended total" column of the table on page 6 under Section II: Financial Bid, item c) represents. Question: Is it the sum of all three hourly rates itemized in the row (e.g., \$50/hour + \$50/hour + \$50/hour = \$150) as it appears to state OR the total budget impact of the three periods (e.g., (\$50/hour x 630) + (\$50/hour x 210) + (\$50/hour x 210) = \$52,500).

Answer 3:

The "extended total" column is the total budget impact of the three periods (e.g., (\$50/hour x 630) + (\$50/hour x 210) + (\$50/hour x 210) = \$52,500).
