Question 14: Could Canada please provide details on the anticipated number of Stakeholder records that will be in the system initially and an estimate of the number of additional records that would be added each year after?

Answer 14: Initial data migration will be approximately 2,000 records in .xls format, approximately 10 GB in size. The number of records will increase as required.

Canada will require server bandwidth of approximately 610 GB/annually to accommodate the data and transactions used by the solution.

Question 15: Could Canada please provide a list of the types of stakeholders that will be maintained within the system? This will assist us in preparation for the demonstration and ensure we have a better understanding of which features might be of particular relevance.

Answer 15: Stakeholders include but are not limited to other federal government departments, provinces and territories, municipalities, professional and regulatory bodies, industry representatives, immigrant-serving organizations and small and medium-sized businesses.
