QUESTION AND ANSWER:

QUESTION 001:

"Each of the Canadian correctional institutions is required to establish and administer bank accounts for each inmate", is this a real bank account maintained at an external bank account or one that is managed by CSC and only exists within the Inmate Accounting System?

ANSWER 001:

The accounts are trust accounts and only exist within the Inmate Accounting System.

QUESTION 002:

Are the canteen items, procured and stored by CSC before delivery to the inmate or is a third party provider like Keefe used?

ANSWER 002:

With very few exceptions, the canteen items are procured and stored by CSC prior to delivery to the inmate.
