**a) At Appendix “D” - Section 1: *Mandatory Evaluation Criteria***

## **B. QUESTIONS AND CORRESPONDENT ANSWERS:**

**Q6:** With respect to rated requirements R-13, R-14, R-15, and R-16, it is recommended that due to the scope and duration of the project that the Senior Engineer role be supplemented with a second engineer with similar and/or complementary experience. This option could provide a greater breadth of technical experience while ensuring coverage and continuity throughout the project. Accordingly, it is requested that rated requirements R-13, R-14, R-15, and R-16 be amended such that the experience points be awarded based on the experience of up to two engineers (e.g., a lead engineer and a deputy).

**A6:** The requirement will remain as stated.

**Q7:** During the JIIFC Industry Engagement Working Group, an assessment was provided by PWGSC that Conflict Of Interest would be under review by PWGSC. [We] request confirmation that any company, contractor etc that worked either directly or indirectly with the JIIFC project Definition, including exposure to SOW and/or development of requirements, should be disqualified from bidding in response to the ref. 1 RFP.

**A7:** Conflict-of-Interest situations are determined on a case-by-case basis in accordance with Standard Acquisition Clauses and Conditions (SACC) 2003 Article 18 - Conflict of Interest Unfair Advantage as amended at Part 2 - Article 2.1 (d) of the RFP. However, due to the required independent interaction between the work performed in the PMESS and DMI contracts, the PMESS and DMI contracts must be performed by different Contractors.

**Q8:** In accordance with SOW Para 2.4-5, the Contractor must update, maintain, and implement the Interface Engineering Plan (DI-ENG-001) which was submitted with its proposal for the development of the Data Mediation Interfaces. The

**corresponding entry in SOW Appendix 5 also indicates that this document is to be submitted with the proposal. The mandatory and rated evaluation criteria included in SOW Annex D (Sections 1 and 2), however, do not include a requirement for this submission with the RFP response.**

**It is recommended that this document be included as a rated requirement and included as part of the submission. The Engineering Plan will provide the bidder's approach to delivering the technical services (i.e. SOW paras 2.4 to 2.6) and will comprise the objective evidence to support the work estimates provided in the financial bid. Without this evidence, the Crown may have difficulty assessing whether a bidder has completed the necessary planning and has the requisite processes and knowledge to execute in accordance with the hours and labour category assignments provided in the financial bid. We recommend that the IEP be used to evaluate a bidder's competency and readiness to execute the technical services work.**

**A8:** The evaluation criteria for the Interface Engineering Plan was omitted from the RFP in error. Please refer to Modifications No 5 for additional Evaluation Criteria.

**Q9:** In accordance with SOW Para 2.5-2, the Contractor must update the initial Interface V&V Plan (forming part of the Contractor's proposal at the Request for Proposal (RFP) stage). The mandatory and rated evaluation criteria included in SOW Annex D (Sections 1 and 2), however, do not include a requirement for this submission with the RFP response. It is recommended that SOW Para 2.5-2 be updated to remove the reference to an initial Interface V&V Plan to be submitted with the proposal and that the initial delivery cited in Annex D (i.e., no later than 20 working days prior to the CDR) be retained.

**A9:** No initial Interface V&V Plan is required at bid submission. Please refer to Modification No 6 above.

**Q10:** Would DND consider adjusting the requirement so that it includes the integration and provisioning of geospatial map data for CPOF for Canada?

**A10:** No. The request is outside the scope of this requirement.

**Q11:** In Article 3.3 Section II: Financial Bid, reference is made to the bidder completing the attached Excel spreadsheet. Has there been an oversight in attaching the Excel spreadsheet to the RFP?

### **3.3 Section II: Financial Bid**

**Bidders must complete Appendix B.2 Service Categories Calculation Table with their financial bid. Note: The Table must remain in Excel format when submitted.**

**(b) Service Categories:**

**(i) Bidders must complete Appendix B-2 of the attached Excel Spreadsheet by providing the Estimated Effort for Phase 1 Part 1 for each and every Labour Category at the Per Diem Rates proposed in Table 1. Where a Labour Category is not required for the performance of Phase 1, Part 1, the Bidder must enter "0" for Estimated Effort.**

**(ii) The Service Per Diem Rate calculated in Column D of Appendix B-2 shall form the Firm Per Diem Rate Per Service Category in Table 2 below**

**A11:** The Excel spreadsheet is identified at ATT1 and can be downloaded in addition to the solicitation document from MERX in either of Canada's official languages.

**Q12:** [Our] technical personnel have reviewed the requirements associated with the subject solicitation and have been unable to locate any mention as to the expected data message formats or the type of protocols/connections expected for these system of systems to interoperate. It is requested that these data message formats as well as the type of protocols/connections expected be provided in order for a detailed response to be presented for evaluation.

**A12:** For operational information systems that are subject to Controlled Goods/ITAR regulations, the data message formats and the protocols for interface connection will be released after contract award. For the remaining systems, the Source System Owner was not able to provide detailed and accurate information at time of RFP release. The analysis phase of the Contract (Phase 1) will address this issue.

**Q13:** It is requested that a three week extension, from the date the information above is provided, be granted to allow for the development of a responsive proposal.
