Questions and Answers:

Question #1: Under Section II: Financial Bid – Pricing Schedule 1 – Firm Price “Firm all inclusive prices including all necessary tools, services, replacement or repair parts, materials, labour and all related costs as detailed in Annex A, Statement of Work” – Can you please clarify if “replacement or repair parts” indicate that all costs associated with the cost of devices, batteries, valves, etc. are included in the prices outlined in Pricing Schedule 1? Or As identified in the Scope of Work – Section 1.4.7.1. All additional parts and labour required to effect repairs to this equipment will be at extra cost to Canada?

Answer #1: Yes this is the cost that you will be quoting us for parts in the 5 year contract. Example: If in year 2 we need some parts for a repair you must follow your pricing you inputted in Year 2 of the pricing schedule.

Question #2: Under Section II: Financial Bid – Pricing Schedule 1 – If unit quantities provided in the tender for devices are not correct, can the contract cost be adjusted accordingly for each additional device?

Answer #2: No, the device count is from the last annual inspection and should be fairly accurate.

Question #3: Under Scope of Work – Section 2.1.2. Scheduling and Planning, Section 2.1.2.2. – Can you provide the last inspection date for the five-twelve-fifteen-twenty and fifty year inspections.

Answer #3: No, I cannot due to the fact that we had no association or history with the contractor that is doing the work presently.
