QUESTION #001

I'm writing to you in regards to the Solicitation No. FP976-120001/B which was published on 16th November, 2012.

The RFP is meant for finding a Privilege Management Software Solution (PMSS) for the Department of Fisheries and Oceans (DFO).

I wish to respectfully inform PWGSC that currently a solution which satisfies the requirements of DFO is under review by SLISA team and has possibility to be available as soon as next week. Provided that a fitting solution is available on the SLISA vehicle, would there still be a need for PWGSC to have this RFP still open. With the best of intentions at heart, I wanted to inform PWGSC against possible duplication of efforts that might happen in having both RFP and SLISA vehicle for same solution.

ANSWER #001

Nothing in the Software Licensing Supply Arrangement (SLSA) method of supply precludes the Government from running a competitive process.

A supply arrangement is not a contract for the provision of the goods and services described in it and neither party is legally bound as a result of signing a supply arrangement alone. Canada may issue contracts against a supply arrangement, however any contracts above \$25K where the contract is being directed by Canada to a specific SA holder and/or re-sellers for a specific product requires Canada to have sole-source justification in accordance with the Government Contracts Regulations and applicable trade agreements.
