Section 2 - Answers to bidder questions

Q1) ANNEX A for buses delivered with no driver, the contractor must be responsible for:

- (a) delivery to the destination specified in the contract
- (b) Pick up at time of expiry or termination of the contract

If DND requested the use of a highway cruiser in Petawawa or Meaford for 2 days, the contractor would have to deliver the bus to Petawawa or Meaford and then pick it up 2 days later when they were done with the bus. Would the contractor receive any compensation for the delivery of a bus or the pick up of a bus at the point where it was requested? Would the "deadhead" mileage charge be permitted under this scenario?

A1) Please see the amendment to the solicitation section for the change which addresses these questions.

Q2) On page 5 of the RFSO the Types of Buses lists are 24, 47 & 55 passenger highway cruisers plus school buses 22 and 44 passengers (24 passenger highway cruisers we refer to as "mini coaches". They have air conditioning, cloth reclining bucket seats, overhead reading lights and luggage storage, TV/DVD/PA systems, but are not highway cruisers. Is this "mini coach" what is being referred to?)

A2) That is correct.

Q3) There is no place to provide pricing for 24 passenger buses in ANNEX B but there is for all other bus sizes listed.

Will you amend the RFSO to include pricing for this size of bus or do you want this size of bus excluded from the RFSO?

A3) Please see the amendment to the solicitation section for the change which addresses this question.

Q4) Finally, there are currently Standing Offers in place with CFB Kingston, CFB Petawawa, CFB Trenton & CFB Bordon. If there is busing required to or from these Bases, why would the existing standing offers not be used for the transportation?

A4) Those Standing offers do not include ASU Toronto.

Q5) Under Annex "C" area of Service – can we indicate areas where we have applications for license pending approval with OHTB?

A5) An Offeror must have pick-up/drop off rights approved prior to the solicitation closing date.

Q6) How/ where do we submit our pricing for delivery and pickup charge for school buses without drivers as we assume we may be required to deliver a bus to any location but not limited to Annex C.

A6) Please see the amendment to the solicitation section for the change which addresses this question.

Q7) Annex A item "B" & Annex B -2 ,For buses rented without driver, is Canada providing fuel?

A7) The bus without driver requirement would be similar to renting a vehicle from a rental location. The bus would come with a full tank of fuel and then Canada would provide the necessary fuel when using the bus. Upon returning the bus it would be returned with a full tank of fuel.

Q8) In the abovementioned RFSO, it states on Part 1-General Information #2 Summary that the period will be for 1 year from the date of issuance, estimated to be July 2012, however there are no dates specified
