Solicitation Amendment No. 3

The following amendment is raised to post questions and answers (Q & A's):

- **Question:** Figure 1 - Laden container configuration on Page 50/59. Please state the density or weights of the pallets specified in the picture. For the calculation sake, we are assuming the weight of all the pallets to be 432 Kg each.

Response: Exact weights for each pallet will be defined in the data validation test (DVT) plan; to be provided upon selection for subsequent bid evaluation phase.

For preliminary calculations, the mean weight for each pallet should take into account the defined volume [1.2m x 1.2m x 1.5m], commodity, and packing density. Using bottled water as the baseline, and an approximate packing density of 75 %, would yield a gross mass closer to 1500 kg. Heavier commodities can then be packed to produce a similar average density.

- **Question:** Solicitation calls for a Data Validation Test (DVT) on a fully assembled and configured system "Of the type proposed for purchase" to validate claims and systems performance. The OEM understands this to mean that all required Annex "A" and "B" Mandatory and Rated Mandatory Specifications must be demonstrated, but that the Optional features can be documented in lieu of demonstration.

This distinction is critically important, as to "build in the options" by its nature will "customize" the vehicle to meet the specific CBSA end-user requirements, and the OEM cannot be expected to reasonably customize its Mobile Large Scale Non-Intrusive System for CBSA specific requirements during the bid evaluation phase. We do agree that any selected Option features actually ordered by the CBSA must be demonstrated and validated prior to delivery.

Please confirm our understanding that Optional features may be acceptably documented at DVT in lieu of full demonstration, prior to an actual order.

Response: For the Rated Options, the following will be used for evaluation:

Please note that for rated options for which "Documentation" may be accepted to demonstrate capability, specific information will be requested as part of the Data Validation Test (DVT) plan to assess the level of capability. Failure to provide any of the requested information at the time of, or prior to, the DVT will be considered inability to provide the option; for which no technical points will be awarded.
