All other terms and conditions remain the same.

Addendum No. 16

1. QUESTIONS AND ANSWERS

Q1: Section 01 50 00 Temporary Facilities and amendment #5 states “provide temporary fence to enclose the construction area of work site”. Does the construction area just include a fence around the new building or is the access road from the entrance off the main road of the institution to the new building location also to be fenced? If this access road is to be fenced, can you please provide information on the length and layout of the access road.

A1: Construction area of work site is self-explanatory: The area of the site on which construction is going to take place. There is no requirement to fence off the full length of the access roadway.

Q2: In details 5, 8, 11 & 12/A-306, there are no anchor bolts shown to fasten the wall sill plate to the foundation. Please provide anchoring method and details for size & quantity of anchors (as per addendum #13 no explosive cartridge tools are permitted on site).

A2: Any anchors will have to be drilled or cast-in, not shot-fired.

Q3: On floor plan A-400.1, Wall Type P3 against the foundations wall and detail 4/A-310 indicates the drywall & vapor barrier wrap continuously around the corner (Grid 5-U & 21-N). There is no indication the same is true at pilasters on Grid 5-Q, 5-T, 5-U, 7-U, 10-U, 13-U, 14-U, 20-U, 21-T, 21-R, 21-N. Please provide details of how Wall Type P3 is constructed at the pilasters.

A3: Vapour barrier is continuous across front face of pilasters throughout. Normal building Best Practice should be followed

Q4: Partition P1.4 & P2.4 are to have plywood sheathing on the washroom side of walls. Washroom #105, 106, 204, 205 & Urineanalysis #117 do not have those wall types, however, they still have WR Accessories to be mounted on the walls. Please clarify if these washrooms are to have 2440mm height plywood backing.

A4: Only inmate washrooms to have continuous plywood. Other washrooms will have localized blocking to support accessories.

Q5: Re drawing # A-008 - per Answer 27 in Amendment #13 there is no such drawing, however in the tender documents we received it certainly exists and is titled "Floor and Wall Finishes Legend", which agrees with the list of drawings on the cover sheet.

A5: Our mistake. The drawings were re-numbered shortly before they went out to tender. Drawing A-008 is the correct reference and it does exist.
