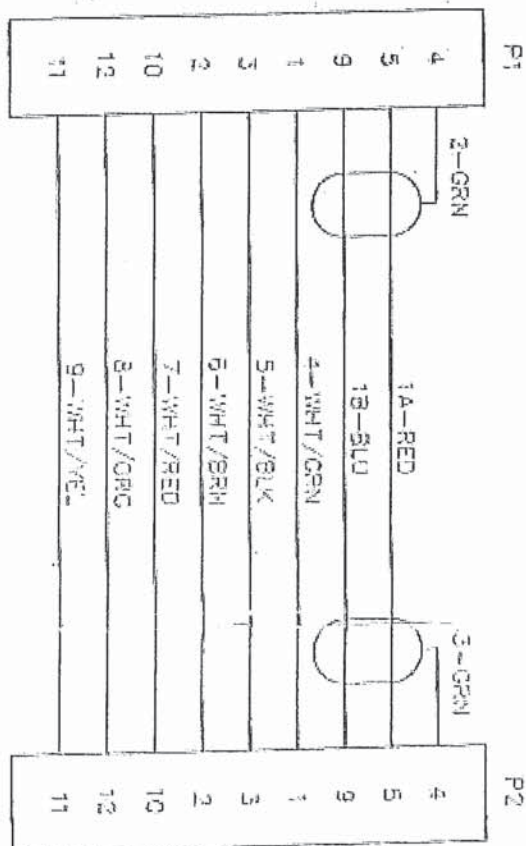

2. CABLE SHALL BE PERMANENTLY MARKED IN APPROXIMATE POSITION SHOWN WITH .06 MIN CHARACTERS IN A CONTRASTING COLOUR. AS FOLLOWS, "36452 ASSY 8981218-1" PER SPAR ASC PCS 10:01 METHOD II.
3. SHIELD OF WIRE #1 SHALL BE TERMINATED AT P1-4 & P2-4 USING ITEM 5 & 6 INSIDE ITEM 3.
4. TERMINATE ITEM 4 CABLE OUTER SHIELD USING ITEM 3, CLOSE TO EXPOSED END.
5. SERVICE WIRE LOOP SHALL BE MIN 1.50 IN LENGTH.
