- Denise Gerstmar went briefly over the tender document.
- The tender date has been amended to close on Wednesday April 18, 2012 et 2PM CST. Please ensure bids are received prior to 2PM. Bids received after 2PM will not be accepted.
- Bidders were advised this is an optional site visit. This site visit is not mandatory. Bids will be accepted from bidders who did not attend the site visit.
- Bidders were advised when completing the tender document to please ensure to sign the front page as well as any pages within the document with blanks.
- Bidders were advised there is a requirement for Commercial General Liability Insurance.
- Jason Veldhouse took all attendees on a tour of the Hugh Cairns Armoury Site. He advised that the Hugh Cairns Armoury is a secure building.
- The areas outside of the fence to roadways and property lines are to be cut.
- The inside fenced area of the compound is to be cut when accessible.
- Jason Veldhouse described the area to be cut at the HMCS Unicorn. The areas to be cut are visible from the street (along 4th Avenue South and 24th Street East). None of the bidders requested a site visit of the HMCS Unicorn.
