This solicitation amendment has been raised to answer questions asked by potential bidders during the tendering period.

1. Is the Milestone Corporate Licence to be included in the total lot price?

Yes. The Milestone Corporate License is to be included as part of the total on the Edmonton Commercial Building part of the solicitation.

2. In regards to Table 7, Item 2, please clarify what is meant by redundant.

The server must be able to function, without loss of live and archived data, even if a part of the storage media fails. CBSA is looking for a storage media that doesn't interrupt the service if something goes wrong.

I.e. There are five appliances in a setup but only four appliances online, the fifth appliance is used in case of one of the other four fails. If one fails, the fifth appliance takes over the failed bank and the failed unit rebuilds itself. All this happens without any service interruption to the operators. It is also connected into a RAID-6 format. This "mechanism" is what we would classify as redundancy.
