Notification of Amendment

You are hereby notified of an update/change in the conditions respecting the use of the solicitation.

Purpose of Amendment

The solicitation amendment is issued to change the Technical Mandatory Criteria and to address enquiries from potential bidders.

Changes to Technical Mandatory Criteria

At Part 4, 1.1.1 Mandatory Technical Criteria

Delete: Tents must be free standing structures with no interior support poles. Weights must be used to install and secure tent structure.

Insert: Tents must be free standing structures with no interior support poles. Either weights or stakes must be used to install and secure tent structure.

At Annex A, Statement of Work, Requirement 3.

Delete: Tents must be free standing structures with no interior support poles. Weights must be used to install and secure tent structure.

Insert: Tents must be free standing structures with no interior support poles. Either weights or stakes must be used to install and secure tent structure.

Bidder Enquiries

Q: What are the foundation requirements?

A: Location of tents will be on an open field with a grass surface.

Q: What should be used for weights?

A: Weights that are capable of securing the tent structure will be acceptable.

Q: Can we anchor to the ground instead of using weights?

A: Yes, anchoring to the ground with stakes is an acceptable alternative to weights.

Q: Is this a single tube building or a truss building?

A: A single tube or truss structure is acceptable.
