TITLE: FUEL - DRUMMED & PALLETIZED

This solicitation amendment is to provide for clarifications regarding the solicitation.

Q1. Was there a previous purchase for fuel for Op Nunavut? If so, do you have a contract number?

A1. DND Yellowknife has no records of previous purchases for fuel for Op Nunavut. Purchases may have been made under the National Master Standing Offer for fuel.

There was a purchase of diesel fuel on 2011-07-15 (Contract W1568-11GM06/001/EDM) for \$16,087.68 from Shell Canada products o/a Bassett Petroleum. No indication if it was for Op Nunavut.

Q2. Naptha is very close to Kerosene. Is Kerosene an acceptable substitute?

A2. Kerosene is not an acceptable substitution for Naptha for DND purposes.

Q3. [The] Naptha must meet a military spec given that the delivery will be for the DND. The information that I require however, and is not provided on the Tender Invitation, is the purpose of use for the Naptha. Several varieties of Naptha exist for different purposes, meaning that the specs for each will be different. If you could please provide me with the MSDS for the type of Naptha you require for this tender that would be very helpful in determining which product I will quote on. Further, if you are privy to the use of the Naptha by the end user, that information would also be helpful.

A3. The NAPTHA is used in military issued Coleman 2 burner stoves and lanterns. The MSDS is not yet available.

Q4. What do you mean by 45 Gallon (205L) Drums of GASOLINE, (WINTER GRADE) (item 1.1) Is there a more detailed spec somewhere.

A4. There is an error in the description for Item 1.1. It should just say "gasoline". Annex "A" has been revised.

Q5. Do you know the location of the Op Nunavut or the location(s) of the delivery to Nunavut?
