Questions (Q) and Answers (A)

- Q1. *"In Amendment 2 the answer to question 5 states: "On page 25 Annex B, yes – as per title of table, firm unit price in Canadian dollars is to be given Carriage Paid to (CPT) for each of the 3 destinations."*

"If the solicitation requires a specific price for each of the 3 destinations in Annex B, what unit price should be used in Attachment 1 to Part 3 on page 9? There is no way to indicate specific unit prices by location on Attachment 1 to Part 3 on page 9."

- A1. On page 9, Attachment 1 to PART 3, firm unit price is not to include freight cost. The pricing in page 9, Attachment 1 to PART 3 and the fourth pricing table titled FOB Plant /Point of origin should match as they represent firm unit price of items without freight costs. Therefore if CORCAN were to order using this pricing table they would be responsible to pay all related freight costs separately or make arrangements for their own means of transportation. I.E. Delivery may be provided by the Standing Offer holder or arranged by CORCAN, using their own trucks. CORCAN reserves the right to choose the most economical means of shipping. The page 9, Attachment 1 to PART 3 pricing table will be used for final evaluation and the total estimated cost of the National Individual Standing Offer (based on estimated quantities to establish total extended price).
