**M1. Bidder's Corporate Experience**

The Bidder must demonstrate that it has been or is currently contractually bound to three (3) external clients (outside of the Bidder's own company) to publish high quality bound publications which include High resolution colour images in English and/or French versions.

During the evaluation no corporate experience gained through internal clients will be accepted or reviewed.

To demonstrate this experience the Bidder must provide the following information for each contract:

- (a) a description of the publication;
- (b) a description of the printing and binding requirements of the publication provided or to be provided by the Bidder;
- (c) the Client information for the Contract

**2) At Annex C delete R3.**

Replace with:

**R.3 Bidder's Experience (15 points)**

The Bidder should provide a list of project undertaken demonstrating the experience publishing Coffee table "library quality" books (high quality case bound book which include high resolution colour images). Preference to books similar in topic to the present Parks requirement (i.e.: nature, marine, historical or First Nations) will be given.
