**Amendment No. 005**

This amendment is being raised to provide responses to Requests for Clarification.

**Requests for Clarification**

**Q1:** Further to your answer to Q2 (pg 4 of 6), Amendment No. 3– if we are submitting for all 4 areas (Eastern, Central, Southwestern, Northern), are we still limited to 12 resumes (6 for senior and 6 for project)?

**A1:** Refer to Amendment No. 003, Requests for Clarification - A4.

**Q2:** We would like to present different teams for each region – how can we highlight the depth of our people and resources?

**A2:** If the Proponent chooses to present different teams for different Regions, a separate proposal should be prepared and submitted for each individual Region on which you intend to bid. The response to SRE 3.2.2, 3.2.4 and 3.2.5 may differ if proposing different teams for individual Regions.

If the Proponent chooses to present the same team for more than one Region, refer to Amendment No. 003, Requests for Clarification - A4. There is no requirement for a firm to have separate teams for each Region as long as it can be demonstrated that all the RFSO conditions are met.

Ultimately, it is to the Proponent to decide how best to present their team(s) in their proposal(s).

All other terms and conditions remain the same.
