This amendment is being raised to provide responses to Requests for Clarification.

Requests for Clarification

Q 1. On page 70 of 96 Section 3.2.3. 2 A PWGSC States:
What the Proponent should provide: (a) A brief description of a maximum of four (4) significant projects completed over the last five (5) years by the firm or its senior personnel;

Would it be possible to change the wording to include projects undertaken by the firm or its senior personnel over the last five (5) years?

I am requesting this change as significant projects usually have multiple phases and can run for an extended period of time where the construction phase of the project may not be completed to date.

A1. No. The wording “ completed” is kept.

All other terms and conditions remain the same.
