In the following work items HD-09, HD-10 and HD 11 you are requesting that the tanks be pneumatically tested you also require that the contractor shall include for Hydrostatically testing each of the tanks. Is the hydrostatic testing to be included in the known work or do you require unit pricing for each tank

"Bidders are to quote for both hydrostatic (water) and pneumatic (air) testing of tanks as known work. Whichever methods of tank testing are not used shall be credited to the Crown by 1379 action. If tank testing is totally waived on any tank by TCMS, then the combined cost for both testing methods shall be credited".

2. Could you please supply the volumes of the tanks listed under HD-11 Void Spaces

The volume of the watertight void spaces in HD-11 are as follows:

Void Space No. 1 = 12.3 cu. m.

Void Space No. 2 = 84.5 cu. m.

Void Space No. 3(P) = 21.9 cu. m.

Void Space No. 3(S) = 21.9 cu. m.

Cofferdam = 4.6 cu. m.

Other listed void spaces are not watertight as indicated.
