In order to provide accurate pricing for Operator Training, we request that the Standing Offer Authority/RCMP specify the locations and total number of training sessions to be provided per year of the Standing Offer.

**2) Correct the answer to Q45 published in amendment 002.**

**Q45** Annex A, Functional Requirements, 34. d.: Individual training packages must be provided at locations identified by the RCMP at call up. In order to provide accurate pricing for Install/Maintenance Training, we request that the Standing Offer Authority/RCMP specify the locations and total number of training sessions to be provided per year of the Standing Offer.

**A45.** Training pricing is to specify the cost per session not including travelling and accommodations which would be paid in accordance with Treasury Board rates applicable at the time of call up. The number of sessions and locations are to be determined by field personnel
