Amendment 001 is raised to answer questions and modify the Solicitation 21K01-117012/A as follows:

1- QUESTION / ANSWER :

Q1 : Under the specifications for Type A, B, C and D, it states that unpainted frames are required so that Corcan is able to paint the frame at its facility. Please note that this requirement presents a difficulty to Corcan may not have been anticipated.

A torsion control mechanism is assembled into the frame using specialized equipment and fixtures under pressure and cannot be manually assembled or disassembled in a safe and effective manner. The mechanism is assembled into the frame after finishing. Assembly of this recline system cannot be done to the raw frame and then have the frame painted as this would result in the torsion system not performing properly. Manual assembly of this system cannot be done safely in a correctional environment without heavy investment in fixtures and equipment.

The manufacture of this product requires large production runs to maintain manufacturing efficiency. Once the frames have been made, finishing must commence shortly after or corrosion of the metal surface will adversely affect the quality of the final finish.

Would Corcan consider changing this requirement from unpainted frame to chrome plated finish?

A1 : No, CORCAN requirements are for unpainted frames (i.e. ready to be painted frames) in our CORCAN shops to provide offender training. No change to the solicitation.

2- MODIFICATIONS :

At Annex A, Section 7.0 DETAILED REQUIREMENTS, 7.4 Armrest:

Delete : *7.4.3 The armrest must be capable of being field installed, in its entirety*
