Amendment no. 003 is raised to provide Questions and Answers to Industry as detailed below:

Q1 – At point 1.1.1. Mandatory Technical Criteria, Pre-Award Sample – Leather Wallet Item 2,; Since this is a new badge, our supplier does not have a badge to make sure that it fits exactly. They have picked one that comes close to it. They will make it to the exact size if we win this bid. It is mentioned that minor observations (up to a maximum of 3) will not be a reason to reject the sample. Please clarify “observation”.

A1 - An observation can be easily corrected. Some examples of observations could be as follows but not limited to: the window for the ID could be a different size, the stitching might be at a different measurement, the cut out shape for the metal badge could be a different shape, and not to fit the metal badge submitted.

Q2 – It is mentioned that only one deviation will result in the bid being declared non-responsive, please clarify “deviation”.

A2- A deviation is an obvious error for example (a pair of pants with only 1 front pocket, when 2 pockets were listed in the specification)

Q3 – At point 16 of the wallet specification (page 2 of 6); it is stated that the case and covers shall be double edge sewn. Where exactly does the stitch go? Is it to keep the actual ID from moving around?

A3 - See the image provided on page 4 for the stitching; cross-reference with points 11 and 12 (page 2).

Q4 – At point 13 of the wallet specification (page 3 of 6), which should read point 18, It reads – Total length (fully open) 18.5 cm (6-5/8”) and on the picture of page 4 of 6, it reads – Length 18.5 (7 1/4”). Which is the correct length ? Also does picture or word override ?

A4 - The correct length is 18.5cm (7-1/4”), the picture is not to scale (as indicated).
