Q34 *SOW parag 4.1.1 – what kind of workstation, what OS and what version?*

A34 The work station is a desk space with access to telephone. A DRDC Laptop, with WINDOWS 7, will be provided to allow connectivity to the Internet and e-mail.

Q35 *Can we use NMSO for equipment purchases after contract award?*

A35 No. The contractor will acquire material through their own procurement system

Q36 *Is there a preferred programming language given the GFE (i.e., ?*

A36 The contractor is responsible for determining the programming language for their design.

Q37 *Will the Crown own all purchased equipment after the project is completed?*

A37 Yes the Crown will own all of the equipment provided under this contract. (see deliverable table)

Q38 *Can we get copies of the military standard documents listed in the SOW at para 2.2?*

A38 Ref 2.2.1 will be provided to the successful contractor. Refs 2.2.2 and 2.2.3 have already been distributed to Bidders

Q39 *Is there an ICD for the Stacomm and if yes can we have a copy?*

A39 There is no ICD for SatComm at this time. DRDC has not yet acquired the SatComm system.

Q40 *In the SOW Section 3.3.2.4 sub-paragraphs g and h are missing – please advise.*

A40 The absence of sub-paragraphs g and h is a typographical error on the part of the originator. No sub-paragraphs g or h were provided

Q41 *What happens if my bid is delayed due to the weather?*

A41 Bids must be delivered to the **Bid Receiving** address provided on the front page of the RFP and received on or before the Closing Date and time stipulated. A bid may be considered delayed in accordance with Standard Instructions 2003 (2012-03-02) 07 Delayed Bids provided the bidder can prove that it was mailed before the bid closing *date* and that the delay is due solely to a delay in delivery that can be attributed to the Canada Post Corporation (CPC) (or national equivalent of a foreign country).

All other terms and conditions remain the same.
