The pumps will not be in-use until October 1st, 2012.

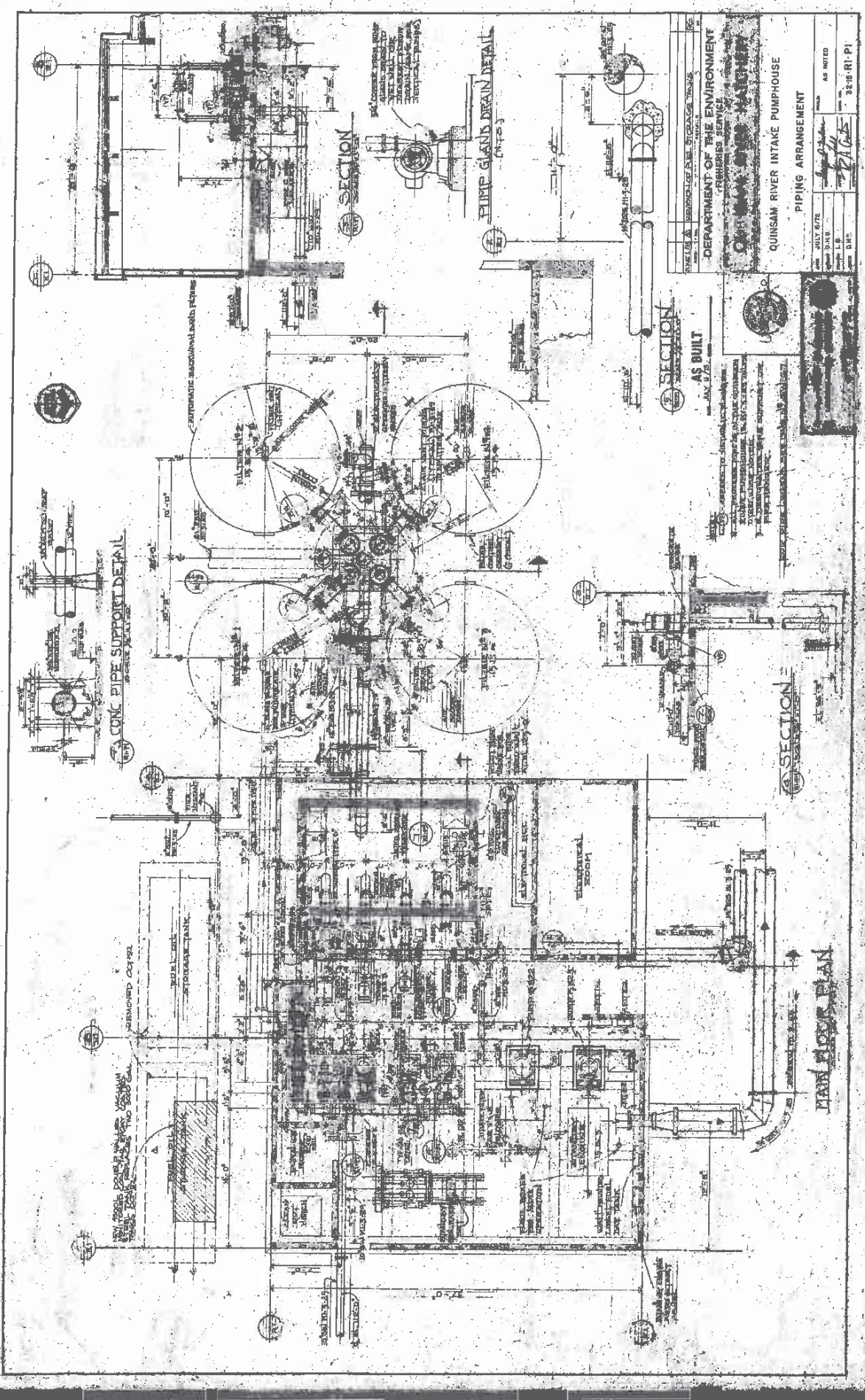
- 2. For worker safety reasons, where are the chambers isolation valves located? Is there a piping drawing available?**

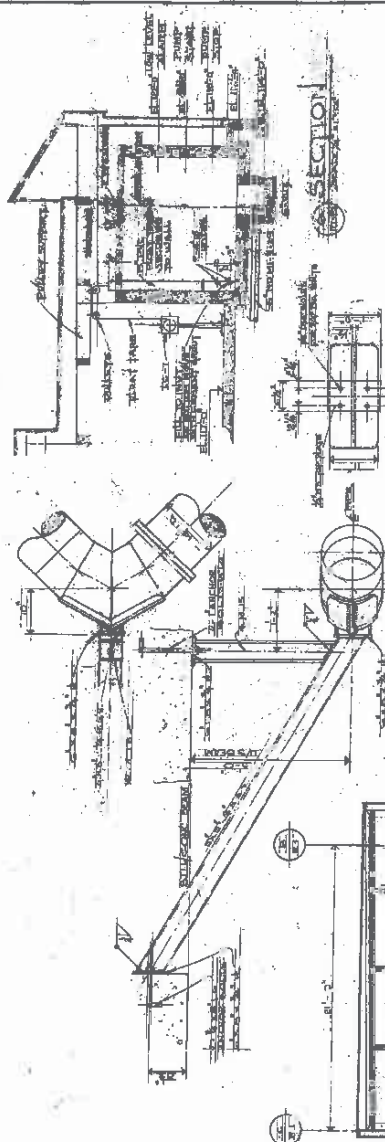

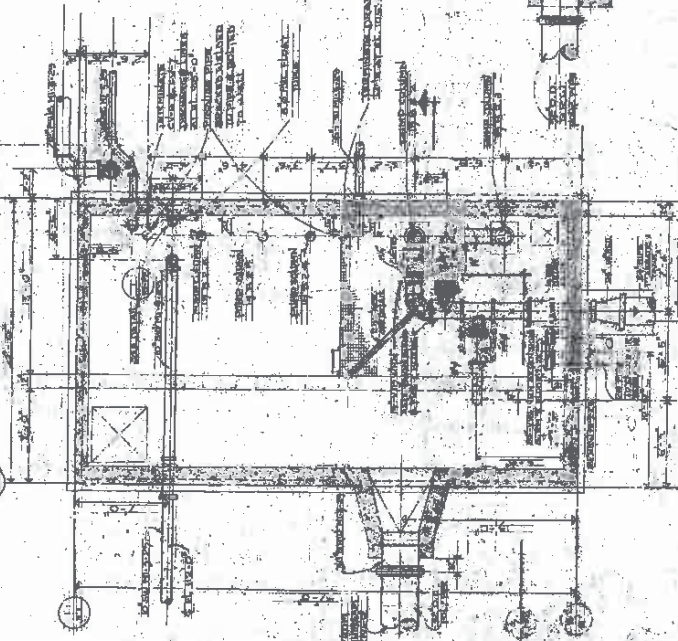

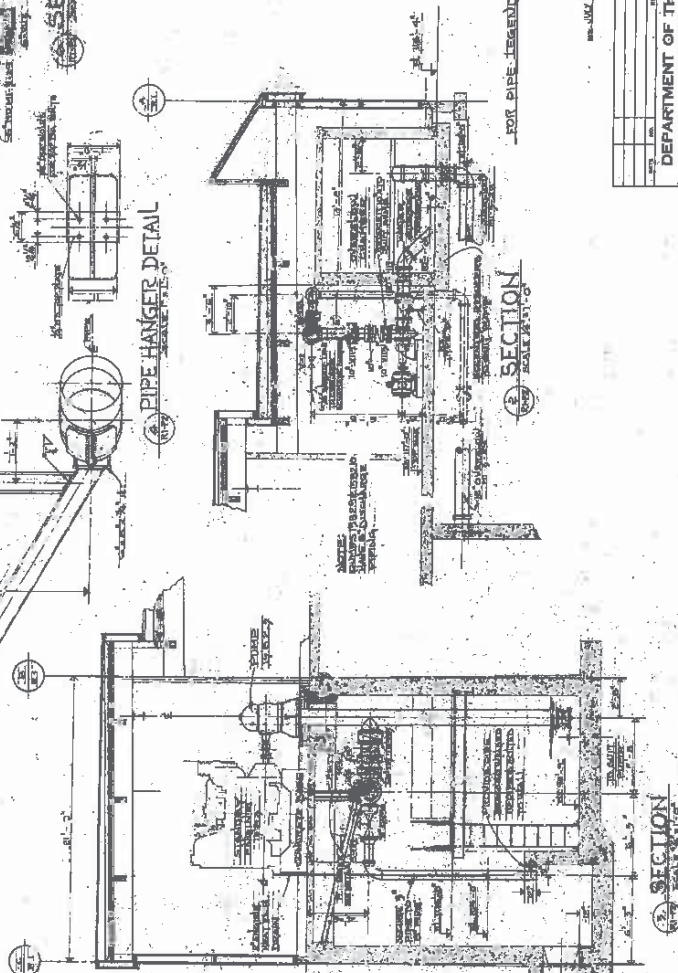
MAIN FLOOR PLAN



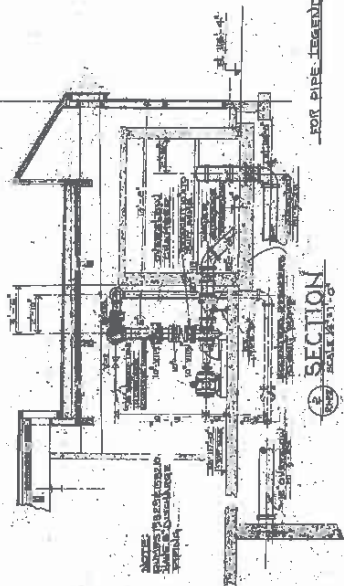
①-DETAIL OF FLOAT SWITCH LC-2
