2. Travel and Living Expenses

Offerors must identify the work location that services will be provided from for each Zone that they are submitting Offers on.

2.1 For Work to be performed at the work location within a Provincial Zone (ie 1.2, 2.1) identified in the call-up:

- (a) For services to be provided within the Province of the specified Zone: The Contractor will be paid its authorized travel and living expenses, reasonably and properly incurred in the performance of the Work, at cost, without any allowance for profit and/or administrative overhead, in accordance with the meal, private vehicle and incidental expenses provided in Appendices B, C and D of the Treasury Board Travel Directive (http://www.tbs-sct.gc.ca/pubs_pol/hrpubs/TBM_113/menu-travel-voyage-eng.asp), and with the

other provisions of the directive referring to "travellers", rather than those referring to "employees"; and

- (b) The Contractor will be paid its authorized travel time, reasonably and properly incurred in the performance of the Work, at a rate of 50% of the all inclusive fixed hourly rate, Actual time for travel will be paid in accordance with the following formula:

$$\text{travel time hours} \times \text{all inclusive fixed hourly rate} \times 0.5$$

- 2.3 Canada will not accept any travel and living expenses incurred by the Contractor as a consequence of any relocation of personnel from outside of the specified Province required to satisfy the terms of this Contract.
- 2.4 All travel including travel time must have the prior authorization of the Project Authority identified in the call-up.
- 2.5 The authorized travel and living expenses will be paid upon submission of an itemized statement supported by receipt vouchers. All payments are subject to government audit.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
