This amendment is being raised to answer questions raised and to incorporate the following information to Solicitation number W0142-12C129/A:

A. BIDDERS' CONFERENCE MINUTES

Held at 1650 - 635 8th Avenue SW, Calgary, Alberta from 10:00am to 11:30am.

A review was done of the solicitation document and the Statement of Work and the following questions were posted:

Q1. Under the Part 4, 1.1.1.b), what kind of proof of experience are you looking for?

A1. Bidder must provide proof such as a resume and any other documentation necessary to demonstrate that the proposed pilot(s) meet the required experience and qualification requested within the solicitation document.

Q2. Under the Part 4, 1.1.1.a), since CARS 702 Certification is for manned aircraft, what certification is required for unmanned aircraft?

A2. See below for answer under amendment to solicitation document.

Q3. What are the capabilities of the PREDATOR, HERMES 450, REAPER and WATCHKEEPER?

A3. PREDATOR and REAPER are both medium altitude long endurance unmanned combat air vehicles designed to carry and release munitions onto a target. HERMES 450 and WATCHKEEPER are unmanned aerial vehicles designed for tactical long endurance missions providing surveillance over a required area. As the capabilities of these UAVs exceeds that required at BATUS, the capabilities of FMV assets provided by the contractor are stated within this SOW and take precedent over the capabilities of PREDATOR, REAPER, HERMES 450 and WATCHKEEPER.

Q4. What is the frequency and range of the Harris 117 radio?

A4. Harris 117 Frequency 30 - 512 Mhz UHF. Range is the line of sight.

Q5. What is the variant of the Rover terminals?

A5. Provision for ROVER 3, 4 or 5 to be used alongside FIRESTORM

Q6. Please explain the Range Template access.

A6. The CFB Suffield training area is vast and spans approximately 2500km². In order to control the land and air space, users (including any FMV contractor) are assigned areas within the training area. The handover of control and movement throughout the training area is as follows:

- a. Air platform checks into CFB Suffield air space who then handover to BATUS Air Ops.
- b. BATUS Air Ops provides the platform operator a route clearance and directions to proceed towards the exercise template that they are participating in.
- c. The Exercise Template Controller will provide the operator a safety and tactical update as the air platform approaches the template. The issue of an exercise story board and their bespoke task

will be provided before take off/launch. On approach to the template, the following template brief will be provided:

- i. Mortar target lines, Max Vertex heights (referred to as the Max Ordinate) Target location and Gun location.
- ii. Gun Target lines, Max Ordinate, Target location and Mortar location.
- iii. Their manoeuvre box, or ROZ.
- iv. Any further situational update required.

Replacement of specific individuals

The replacement of specific individuals clause was explained to the attendees that if for any reason that they need to replace the individual they proposed at bid closing, the replacement must meet the criteria used in the selection of the Contractor, including the technical point rated evaluation.

B. QUESTIONS AND ANSWERS

Q1. Please confirm that compliance with the Statement of Work is a mandatory requirement.

Q1. See amendment below to Mandatory Technical Criteria.

Q2. Please confirm if the Contractor must provide both Electro Optical (EO) and Infra Red (IR) sensors simultaneously on the aircraft?

A2. Yes, the Contractor must provide both EO and IR sensors. See amendment below.

Q3. Please confirm the Contractor must be capable of dynamic re-tasking mid-sortie and as of a result the minimum requirement under the Technical Point Rated criteria, Section A.1 will have a threshold score of 20 points.

A3. See amendment below. It is preferred that the aircraft be capable of re-tasking mid-sortie, but will not be a minimum requirement.

Q4. Please confirm that CFB Suffield will not charge any additional fees to Contractors who require access to the Base in order to support the work involved in this contract?

A4. There will not be any additional fees charged to Contractors to access the Base.

- 2) Proof of experience is required with the bid to validate experience of proposed pilot(s) or mission commander(s).

 - i. Manned aircraft:
 - a. Must provide documentation showing the pilots and aircrafts are Air Operator Certified under CARS 702 by Transport Canada Civil Aviation (TCCA).
 - ii. Unmanned aircraft:
 - a. Must provide a Special Flight Operating Certificate issued by Transport Canada Civil Aviation in accordance with CAR 602.41.

1.1.2 Canadian Military Airspace access

Prior to contract award, the recommended bidder must be approved by DND/CF to operate in Canadian Military Airspace, which includes an airworthiness assessment.

The period of the Contract is from date of Contract to March 31, 2013 inclusive. Work must be completed from date of award to October 31, 2012 inclusive.

4.2 Option to Extend the Contract

The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to one additional one year period, from April 1, 2013 to March 31, 2014 inclusive (Task authorized work to be completed during the period of May 1, 2013 to October 31, 2013), under the same conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions as set out in the Basis of Payment.

Canada may exercise this option at any time by sending a written notice to the Contractor at least thirty (30) calendar days before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.

In consideration of the Contractor satisfactorily completing its obligations under the Contract, the Contractor will be paid a firm price for a cost of \$TBD. Customs duties are included and Goods and Services Tax or Harmonized Sales Tax is extra, if applicable.

For the firm price portion of the Work only, Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.

No increase in the total liability of Canada or in the price of the Work resulting from any design changes, modifications or interpretations of the Work, will be authorized or paid to the Contractor unless these design changes, modifications or interpretations have been approved, in writing, by the Contracting Authority before their incorporation into the Work. The Contractor must not perform any work or provide any service that would result in Canada's total liability being exceeded before obtaining the written approval of the Contracting Authority. The Contractor must notify the Contracting Authority in writing as to the adequacy of this sum:
 - a. when it is 75 percent committed, or
 - b. four (4) months before the contract expiry date, or
 - c. as soon as the Contractor considers that the contract funds provided are inadequate for the completion of the Work,

whichever comes first.
3. If the notification is for inadequate contract funds, the Contractor must provide to the Contracting Authority a written estimate for the additional funds required. Provision of such information by the Contractor does not increase Canada's liability.

The contractor's aircraft must be fitted with a 360 degree Electro Optical (EO) and Infra-Red (IR) sensor, with image fidelity sufficient to RECOGNISE people from 3000 ft and conduct wide area surveillance. The FMV feed must be sufficiently high resolution to enable Positive Identification of armed individuals or vehicles in order to allow targeting procedures to be practised by the training audience and targeting decisions to be made with clarity. The EO/IR capability is required for all training during the day and at night. Contractors must be able to switch between EO and IR whilst on task in the air. This sensor is to be day, low-light capable and night time capable. Desirable is the ability for the IR sensor to display white hot and black hot. The aircraft is to operate when the cloud-base is 700ft or above during the day and 1000ft or above during the night. The aircraft must be capable of dynamic re-tasking mid-sortie.
