On July 11, 2012, the Minister of Public Works and Government Services Canada announced further action to strengthen accountability and crack down on firms convicted on certain criminal charges that seek to do business with the Department. PWGSC is extending the list of offences that render companies and individuals ineligible to bid on contracts.

The new measures are effective immediately and will be applied to all future PWGSC solicitations and real property transactions. These measures will also allow the department to terminate future contracts and leases with companies or individuals that are convicted before the end of their contract or lease. For further information on the implementation of the new measures for PWGSC contracts, please visit the buyandsell.gc.ca website.

This Mandatory Requirement is added:

1. Code of Conduct Certifications - Consent to a Criminal Record Verification

1.1 Bidders must submit with their bid, by the bid solicitation closing date:

- (a) a complete list of names of all individuals who are currently directors of the Bidder,
- (b) a properly completed and signed form (PWGSC-TPSGC 229) for each individual named in the list.

The Evaluation Criteria is amended:

4.1 Mandatory Evaluation Criteria - Goods:

The following mandatory factors will be taken into consideration in the evaluation of each bid:

- (A) compliance with proposed pricing methods,
- (B) price,
- (C) manufacture and Parts Traceability for all items; and
- (D) material condition;
- (E) terms and conditions as outlined in the RFP/Contract document
- (F) Code of Conduct Certification - Form PWGSC-TPSGC 229
- (G) Transportation cost information (US suppliers)

All other terms and conditions remain unchanged.
