Title: Removal and Disposal of Garbage and Recyclable Materials, DND Edmonton Garrison

This amendment #002 is raised to answer questions for solicitation W0127-12AES6/A as follows:

Question 1: In Annex B, section B, you are wanting a price/pickup, however we usually quote based on per month, so if we put an amount beside 3 cu. Yd, is it assumed you will take that rate and multiply it by 3 for the yardage?

Answer 1: Refer to page 6 of 37, Part 4, 1.2 Financial Evaluation: Unit prices will be multiplied by the estimated usage for each of the three years and the two additional option years in the Basis of Payment, Annex "B".

Question 2: You have option Yr 1 and option Yr 2, but being that these are optional years, do we NEED to put a price on these?

Answer 2: Refer to page 29 of 37, Annex "B", Basis of Payment: Prices must be provided for each line item and as per format shown below.

Question 3: In Annex B, section C, you have roll offs on a \$/pickup/bin, but again, roll offs are based on an amount per lift, plus on a \$/MT amount, so how do you want us to put that on the current sheet? Normally there is a spot for lift rate and MT rate. With that being said, can you clarify this; is #3 under Section C) Roll off Garbage pick where we put lift rate? And #4 under Section C) removal charges, where we put MT rate?

Answer 3: In Annex B Section C "AS AND WHEN" REQUIREMENT under #3 "Roll Off Garbage Pickup" this is where the lift rate per bin applies and the pickup charge per bin applies.

Question 4: Section C) #5 – Landfill charges, it says dry/wet Garbage – I am assuming this is the answer to my question, but to clarify, this is where you want the per MT rate. If that is so, then is the section above (4) Removal Charges, does this just refer to removal of bin?

Answer 4: In Annex B Section C "AS AND WHEN" REQUIREMENT under #5 "Landfill Charges" this is where the MT rate applies.

If your proposal has already been submitted, you may wish to revise it.
