Add item 2.4: Manual Transfer Switch

- .1 Double-Throw Safety Switch.
- .2 Triple padlocking capability. Two on door and up to three 3/8" shank locks in 'OFF' (centre) handle position.
- .3 Four pole.
- .4 The handle operating mechanism actuates either the upper or lower switch. When the handle is in the centre position, both switches are OFF.
- .5 The handle and door are interlocked to keep the door closed when a switch is ON and hold the handle OFF when the door is open.
