- KEYNOTE LEGEND:**
- (A) -BUILDING ENERGY MANAGEMENT SYSTEM, CONNECT TO RESERVOIR.
 - (B) -PROVIDE 1.5m X 1.5m CONCRETE PAD AT ALL PERSONNEL DOORS, PROVIDE 1.5m X 60m CONCRETE SIDEWALK. CONFIRM LAYOUT WITH DEPARTMENTAL REPRESENTATIVE.
 - (C) -TEMPORARY FENCE AROUND SITE AND LAYDOWN AREA PER SPECIFICATIONS.
 - (D) -TIE INTO EXISTING WATER SERVICE
 - (E) -TIE INTO EXISTING FIRE SERVICE

 - (L) -SECURITY CONDUIT FROM G.O. LAN ROOM TO PRINCIPAL ENTRANCE BUILDING.
 - (M) -TURNAROUND TO BE PROVIDED DURING EXCAVATION OF PIDS ROAD.
 - (N) PA SYSTEM TO MAIN BUILDING AT MCCP.
