This solicitation amendment is raised to advise bidders of the bidders' conference and one on one meetings during March 25 and 26, 2013. The solicitation document indicated that Canada had planned to hold the bidders' conference the week of March 18, 2013. However, the logistics required to hold the bidders' conference did not permit scheduling the conference during the week of March 18, 2013.

### **Bidders' Conference**

A bidders' conference will be held in Ottawa, Ontario on March 25, 2013. The conference will begin at 9:00 am. The scope of the requirement outlined in the bid solicitation will be reviewed during the conference and questions will be answered. It is recommended that bidders who intend to submit a bid attend or send a representative.

Bidders are requested to communicate with the Contracting Authority before the conference to confirm attendance. Bidders should provide, in writing, to the Contracting Authority, the names of the person(s) who will be attending and a list of issues they wish to table at least five (5) business days before the scheduled conference.

Any clarifications or changes to the bid solicitation resulting from the bidders' conference will be included as an amendment to the bid solicitation. Bidders who do not attend will not be precluded from submitting a bid.

### **One on One Meetings**

Following the bidders' conference, the project team is willing to conduct one on one meetings with bidders. The intent of the one on one meetings is to provide an opportunity for fluid discussion of the requirement with the objective to identify key areas of the solicitation and requirement that are either not clearly communicated or addressed.

Bidders must submit the completed meeting request form appended to this solicitation amendment to the Contracting Authority at least five (5) business days before the scheduled bidders' conference.

The one on one meetings will be scheduled between 1:00 pm and 3:30 pm on March 25, 2013 and between 9:00 am and 3:30 pm on March 26, 2013. Scheduling the one-on-one meetings will be based on the chronological order of the meeting request forms received by the Contracting Authority and the office location of the attendees. The objective is to schedule one on one meetings with bidders who have travelled the furthest to attend the bidders' conference during the same day of the bidders' conference.

Each one on one meeting will be limited to 30 minutes in duration.

To ensure integrity of the procurement process, all One on One Meetings will be recorded and summarized. Key discussion items raised during the meetings that result in a clarification or change to the bid solicitation will be published as an amendment to the bid solicitation.
