This Solicitation amendment is raised to answer questions received from Bidders.

A. QUESTIONS AND CORRESPONDENT ANSWERS:

QUESTION 1

With the release of Amendment #9, it has restructured the way in which M1/R1 reads. As per the changes in Amendment #9 (Attachment 3.2 – M1), “The Bidder must demonstrate that all provided resources have completed, for each resource category, at least 50% of the tasks for such category detailed in section 3 of Annex A (SOW).”

Up to this point, companies only had to certify (as per Appendix A to Attachment 3.2) that the resources claimed for billable experience against M1 performed at least 50% of the associated tasks within the category they were being mapped against. In addition, it would be understood by way of the cross reference to the project references, that the references cited would validate/verify what was being claimed. Based on Amendment #9, is the Crown now requesting attached SOW's for every billable resource claimed in substantiation of M1/R1 based on the change in terminology outlined in italics above? Please clarify how you would like us to “demonstrate” 50% of the SOW.

ANSWER 1 - By submitting a bid, the Bidder certify, as per Appendix A to Attachment 3.2, that the work delivered by the Categories of Personnel for each referenced Contract includes at least 50% of the associated tasks listed in the Statement of Work at Annex A of this bid solicitation for each Categories of Personnel.
