The purpose of this amendment is to publish answers in response to questions received regarding this TBIPS SA RFP.

THE FOLLOWING CLARIFICATION FORMS PART OF THIS TBIPS SA RFP:

Question 1) In regards to resource A.2 Functional Analyst - Generalist (level 2), R-4 states:
“The bidder’s proposed resource should have experience as a functional analyst on PeopleSoft HRMS implementation projects. For project experience to qualify, the resource must have been on the project for a minimum of 12 months within the last 10 years.”

Would the crown consider changing the number of months required from 12 to 6?
