Question and Answer Set 1.

Question 1. We see that Canadian Content is part of this solicitation. What are the grounds for this clause's inclusion?

Answer 1. Because the requirement falls under the AIT (Agreement on Internal Trade) only, Canadian Content could apply. The requirement is subject to a preference for Canadian goods. If there are less than 3 bids with valid Canadian Content then all bids will be evaluated.

Question 2. Will a performance specification be forthcoming or will this RFP be procured under ACAN rules?
