Q1. With reference to the tent contract; during my inspection of the tents I noted that several door screens and several window screens were damaged. In addition to that, several screens both door and window were missing altogether. The cost to repair a window or door screen is lower than the cost to totally replace a screen especially window screens due to metal prices and the like. When we are bidding upon repairing the screens is our price different if it involves repairing vs. replacing.
