Please note the following questions and answers:

- Q.1 Amendment 5 of the subject RFP indicates that "Accommodations and meals are not fully provided at no cost to the Contractors when they are assisting in program rotations at the Canadian Forces College"; however, can the Crown confirm if accommodations and meals are available to contractors at their own expense? If so, would the Crown indicate what those costs are?
- A.1. Although accommodations and dining facilities are located on site at the Canadian Forces College, these facilities are identified for use by staff and students assigned to the College and are not necessarily available to Contractors. Should surplus capacity render them available, a request to have access to these facilities on a cost recovery basis would be considered by the Project Authority and the College Staff on a case by case basis. As such, costs associated with usage by contractors will not be discussed as part of this proposal.
- Q.2 Would the Crown consider a two week extension to allow sufficient timing to capture potential resources returning from winter?
- A.2. No extension will be granted. The Solicitation closing date remains unchanged.
