4. Staff .1 For routine cleaning, the Contractor shall maintain a staff of six (6) people for a minimum of 8 hours per day each, plus an on-site working supervisor for a minimum of 8 hours per day. Contractor must have available a security-cleared alternate to cover for any other person unable to perform duties.

QUESTION

Is that all paid time?

ANSWER

Contractors are required to pay staff according to the laws in force in Prince Edward Island.

Contractors' price provided in the Unit Price Table includes wages, traveling time and costs, allowances, supervision, liabilities as employer, insurance, and the use of all tools, tackle, etc., overhead, profit, and all other liabilities whatsoever.
