Generally, the HF Evaluation will evaluate the Driver/Passenger Station, the design and operation of the controls, external and internal visibility, the cab environment and ride quality. These will be specifically evaluated via the Evaluated Categories described in detail at article 2 herein.

Each user will provide their evaluations of each Test Article while attired in the following four conditions:

- a. Condition 1 (C1): standard CF combat uniform (CADPAT) with soft cap
- b. Condition 2 (C2): standard CF combat uniform (CADPAT) with Full Fighting Order including ballistic plates
- c. Condition 3 (C3): standard CF combat uniform (CADPAT) with soft cap and limited winter order, specifically mukluks and gortex gloves.
- d. Condition 4 (C4): standard CF combat uniform (CADPAT) with Full Fighting Order including ballistic plates and with Night Vision Goggles (NVG) mounted on the

helmet

Static evaluations will be conducted by users attired in C1, C2, C3 and C4.

Dynamic evaluations will require each user to drive each Test Article three times as follows:

- a. daytime, in C1, approximately 180 km
- b. daytime, in C2, approximately 180 km

c. night-time, in C1, approximately 40 km

The driving course will be a set course combining both improved and unimproved surfaces as described at Part 4, Attachment 5, Section 2, Schedule 5-2, Appendix 1, Article 4.2 Test Profile: 500 km Mission Profile.

Each user will be given the same questionnaires to provide their evaluations of all of the Evaluated Criteria.
