Solicitation Amendment 002

The purpose of this amendment is to provide an update after the optional bidders conference was held in Yellowknife on Thursday February 7th, 2013.

The following people were in attendance at the Bidders Conference;

A Project overview was provided by both Project Managers as well as site photos. Brad McFadden went over the RFP and summarized the important areas including the mandatory submissions required at bid closing. A CD containing additional site information (Phase 3, Rap and road video) was handed out to the contractors in attendance. It is available upon written request only at which time it would be mailed out.

The following questions were asked during the bidders conference;

Q1 Who is going to manage the land farm ?

A1 The Contractor is responsible for the management of the selected remediation method.

Q2 what line item is the offsite transport of contaminated soils included in and what happens if there is additional contaminated soils to be shipped off-site ?

A2 Provision for the transport of contaminated soil to an off-site disposal facility is included in line item 02 41 16-11, Disposal of Non- Hazardous Waste (Demolition, Debris Removal and Contaminated Soils), which is a Provisional Cost Sum Item where the contractor submits invoices or other back up and is reimbursed for approved costs. If additional contaminated soils are generated during the remediation construction, then the additional soil containers along with the off-site transport and disposal of these additional soils would be provided through a Task Authorization or Change Order.

Q3 There was uncertainty in BOPC -! Cost Breakdown table in the RFP

A3 It was clarified that the table in question was to provide a breakdown of the costs that were equal to that of the line item total cost which was the first item in Section 1.
